### **Answer**

## Business specific to the Aboriginal and Torres strait Islander Advisory Group

Standing Agenda items include:

- 1. Minutes approval and actions from the last meeting
- 2. Southern Entry art commission and Reg Saunders content progress
- 3. Glazed Link and Anzac Hall design progress updates for feedback
- 4. Frontier conflict planning and program
- 5. Other items as required (multimedia, graphics, visitor experience, architectural features and finishes, gallery orientation and wayfinding etc)

Aside from the subject of Frontier conflicts, the Advisory Group is currently focussed on the experiential design, visitor experience and content development including identifying First Nations veterans who served in modern conflicts for their story inclusion in the new Anzac Hall galleries (Afghanistan, Peacekeeping, Gulf War, Iraq War, Maritime Security and North Iraq and Syria).
