Block 3 Section 39 Campbell - Early Works associated with the AWM Redevelopment

I refer to the works approval application, drawings and supporting information on the above works submitted to the National Capital Authority (NCA) for consideration on 12 March 2021. I also refer to further information submitted on 12 May 2021, 26 May 2021 and 28 May 2021.

The NCA advises that:

Works Approval is granted pursuant to Section 12(1)(b) of the *Australian Capital Territory* (*Planning and Land Management*) *Act 1988* for Early Works associated with the AWM Redevelopment located at Block 3 Section 39 Campbell (Australian War Memorial) as shown on the attached Drawing Schedule and as outlined in the supporting documentation submitted.

The term "works" is defined in the Act to exclude anything done inside buildings or structures. Under the Act works approval may be given where the works are in accordance with the National Capital Plan. This works approval is given only on the basis of satisfaction that the works are in accordance with the National Capital Plan and does not constitute building approval. It does not constitute any form of warranty as to the structural sufficiency of the proposed works, as to safety of the works or as to safety of the performance of the works. It is the responsibility of the applicant to ensure the safety of the works and the safety of the performance of the works and to ensure that any approvals required under separate legislation are also obtained.

Please Note:

- This approval does not prejudice the NCA's consideration of any other Works Approval matters related to the site.
- 2. All existing trees adjacent to the works area are to be adequately protected for the duration of the works. Where works are conducted near trees the applicant is to comply with Australian Standard 4970-2009: The Protection of Trees on Development Sites. Please note there should be no open excavation or trenching within the Tree Protection Zone (TPZ) of any tree as determined by AS4970-2009. Tree protection measures are to be implemented for any trees within or adjacent to the works area according to Section 4 of AS4970-2009.
- 3. Temporary fencing installation is to be in accordance with Australian Standard AS4687-2007 Temporary Fencing and Hoardings.

- 4. All relevant ACT Government approvals are to be obtained prior to the commencement of works.
- 5. A minimum of 250 native trees are to be planted are to be replanted. New tree planting must be specified advanced stock. Further detail on proposed species and locations will form part of a separate works application.
- 6. A Construction Environmental Management Plan (CEMP) is to be submitted to worksapproval@nca.gov.au prior to commencement of works.
- Works are to be undertaken in accordance with ACT Government Transport Canberra and City Services Authorisation of Temporary Traffic Management Plans (TM/8026) dated 22 April 2021.
- 8. The project perimeter hoardings must be removed by 30 June 2024.
